

**TOWN OF WEST GREENWICH
INVITATION TO BID
LIQUID BITUMINOUS MATERIALS AND SERVICES**

The Town of West Greenwich is seeking bids for Liquid Bituminous Materials and Services for the West Greenwich Department of Public Works. Sealed bids will be received at the Town Clerk's Office, 280 Victory Highway, West Greenwich, Rhode Island until 4:00 p.m. on May 17, 2024. Bids will be opened at a bid opening ceremony in the Town Council Chambers on May 22, 2024 at 11:00 a.m.

Specifications and information for bidders may be obtained at the Town Clerk's Office or the town website: wgtownri.org

Each bidder shall submit with his bid a certificate of insurance naming the Town as "Additional Insured". These certificates shall contain a provision that coverage afforded under the policies will not be reduced or cancelled unless at least fifteen (15) days prior written notice has been given to the town. Insurance shall be written with a limit of liability of not less than \$1,000,000 for all damages arising out of bodily injury, including death, at any time resulting there from, sustained by any one person in any one accident; and a limit of liability of not less than \$1,000,000 aggregate for any such damages sustained by two or more persons in any one accident.

The right is reserved to waive any informalities in or reject any and all bids received, and to award the contract to any of the contractors bidding the work if, in the Town of West Greenwich's opinion, the best interest of the Town will thereby be promoted. No award will be made to any bidder who cannot satisfy the Town of West Greenwich's Department of Public Works, that he has sufficient capital, plant, equipment and personnel to enable him to perform and complete the work successfully. The owner's decision or judgment of these matters will be final, conclusive and binding. Conditional or qualified bids will not be accepted.

Each bid must be submitted in sealed inner and outer envelope bearing on the outside the name of the bidder, his address, and the name of the project for which the bid is submitted. Both envelopes, containing this information and clearly labeled "LIQUID BITUMINOUS MATERIALS AND SERVICES and are to be prepared in this manner so as to guard against opening prior to the time set therefore.

The Town of West Greenwich will provide interpreters for the hearing impaired at any meeting provided a request is received three (3) business days prior to said meeting Individuals requesting interpreter services for the hearing impaired must notify the Town Clerk's Office at 392-3800 72 hours in advance of the hearing date.
