E. UNFINISHED BUSINESS

1. DISCUSSION AND VOTE ON RENEWAL OF KENNEL LICENSE FOR JEWELSET KENNEL

Town Administrator Breene explained the complaint regarding the barking dogs.

Animal Control Officer Tavares explained she had received a complaint for barking dogs in 2011.

Julianne Waters from Jewelset approached the Council regarding the history of her license and reasons she holds a license. She explained she understands she does not like the barking dogs and measures she has taken to minimize the barking. She further explained times have changed with the increased development of the area.

Councilman Mulcahey questioned how many dogs she has. Ms. Waters stated five.

Animal Control Officer Tavares explained the ordinance and the allowance of dogs.

Holly Howard, 110 Plain Meeting House Road stated reasons why she sent the complaint and further explained that she does not want to deny the license; however in the last eight years there are barking dogs and with the development of the neighborhood the Council may receive more complaints for there is no signage identifying the kennel.

Animal Control Tavares stated a sign is not required and explained complaints should be directed to the Police Department and fines will be issued after a half hour of continual barking.

Council Vice President Woloohojian requested residents to report complaints.

Animal Control Tavares further explained the protocol with complaints.

Discussion ensued on reporting dog barking.

Council President Tourgee explained the recent changes to the dog ordinance with regards to increase fines.

Tax Assessor Randall stated New Business item 3 and 4 are the same just from different communities. She further explained the effects if enacted. The loss of tax revenue and mandate

a special exemption for a limited class of properties and developers and cause the current tax payers to bear the financial burden.

Town Administrator Breene further explained effects.

Discussion ensued on action for opposition.

Council Vice President Woloohojian moved to send a letter in opposition of H5044, S0559 & H5173 to our local Senators, Representatives and Governor Raimondo. Councilman Andrews seconded.

Tax Assessor Randall explained legislation regarding impact fees.

5. DISCUSSION AND VOTE ON PENSION SETTLEMENT

Town Solicitor Ursillo explained the settlement that was reached on the pension; which gives back approximately 2 to 2.5% more in addition to the 7.5%. He further explained the cost of the lawsuit for those who continue to challenge the settlement. He also explained each community could opt out; however would not make sense for municipalities would be paying the 90% instead of the 10%. The general assembly bill will bind the municipalities.

Councilwoman Rekas Sloan questioned what the effect financially would be on West Greenwich. Town Solicitor Ursillo explained the savings.

Discussion ensued on notification of pension settlement.

Councilman Andrews questioned if the Council could approve if Police Union did not. Town Solicitor Ursillo advised the Police Union has no bearing on what the town decides.

Discussion ensued on effects of settlement.

Councilman Mulcahey moved to support the Statewide Pension Settlement. Councilman Andrews seconded. VOTED: Tourgee - aye, Woloohojian - aye, Andrews - aye, Coutcher – aye, Mulcahey –aye

G. PUBLIC FORUM

Council Vice President Woloohojian explained mailing from the school committee and requested Tax Assessor Randall who served on the Charter Committee to explain the three charter amendments.

Tax Assessor Randall explained the following Charter amendments of the Exeter-West Greenwich Regional School District: Change the definition of a quorum for regional school committee purposes. If amended, a quorum would now require four members from the committee and that at least one person from each town in the school district be present. Change the annual budget process. The budget process will still require an all-day referendum in both member towns. However, the purpose of the all-day referendum will be to either approve or reject the school committee's proposed budget. There will be no amendments made to the school committee's proposed budget. In the event that the voters reject the school committee budget at the all-day referendum, the school committee will be required to meet, propose a new budget, and submit the same to the voters again utilizing the same all-day referendum process. In the event that the school committee is not able to get a budget approved by the voters, the applicable provisions of RI General Laws will apply. (Per current Rhode Island General Law 16-7-23, the prior year's budget would prevail)Change the payment of the apportioned cost dates from September 1, December 1, February 1 and June 1 to September 15, December 15, March 15 and June 15.

Town Administrator Breene requested Town Planner Paquet and Public Works Director Wright to explain the grants received for the street sweeper.

Town Planner Paquet explained the acquisition of the grant of \$115,000 to obtain a new sweeper.

Public Works Director Wright explained the sweeper will eliminate dust, the roads would be much cleaner and sweeping will be more efficient.

Councilwoman Rekas Sloan questioned the time frame. Public Works Director Wright explained it will take some time to obtain.

Council President Tourgee stated the old sweeper was 22 years old and requested the residents be patient with the delay of sweeping roads.

Council Vice President Woloohojian moved to close the meeting and to go into Executive Session at 8:18 P.M. pursuant to RIGL 42-46-5, (A), 6 Prospective Business or Industry Big John's LLC and West Greenwich Solar LLC; pursuant to RIGL 42-46-5, (A) and RIGL 42-46-5, (A), 2 Potential Litigation with the Town of East Greenwich.
