## B. WORK SESSION ON FY 2016/2017 BUDGET

Town Administrator Breene advised the Council on the 2016 proposed budget and stated we look to be in good shape. He also advised on the following comparison from 2005: General Government has decreased 5.6%, Education has increase 56%, Public Safety has increased 61.3%, Public Works increased 20% and Community Service has increased 357%.

Town Administrator Breene advised on the proposed salaries increase for 20 16: General Government 3%, Fire Is contractual at 2%, Police is contractual at 2% and Dispatch is contractual at 3%.

Discussion ensued on the surplus.

Tax Assessor Randall advised on the proposed revenue.

Discussion ensued on transportation aid.

Discussion ensued on equipment needs for the Public Works Department.

Town Administrator Breene advised he will request Public Works Director Wright to attend the next Budget Workshop.

The Fire Department budget was reviewed and it was noted the 60,000 was not requested.

The Police proposed budget was reviewed.
